PLEASE NOTE: This workshop week is now full. Your child has now been allocated to the workshop that was indicated on their application form.

What you need to bring:

- The completed form included in this pack to be processed during registration on the first day.
- Plenty of water, snacks and a packed lunch for each day.
- Comfortable & sensible shoes and clothing suitable for activity. NO crocs, flip-flops or wheelie trainers please!
- All necessary medication – this will be placed on a designated medicine table for easy access and should be clearly labelled.
- Your completed ticket request letter for the final performance.

What you need to know:

- It is not advised that children bring any valuable items with them to Show in a Week. MP3s/iPods and mobiles cannot be switched on or used during the workshops and valuables are left at the owner's risk.
- Children will not be allowed to leave the Loughborough Town Hall premises under any circumstance whilst they are signed in and attending a session (see **Child Safety** section). **Please note that children will not be able to self sign in or out.**
- The sessions will run from 10.15am-3.30pm each day and all children must arrive and be collected on time. Attendance for all days is important.
- **Please ensure your child arrives at the Loughborough Town Hall Box Office in good time to allow for a prompt 10.15am start each day.**
- Should you need to report an absence please contact the Box Office: 01509 231914.

What you need to know (continued):

- The emphasis of Show in a Week is fun and inclusive of all abilities. To ensure that all children are able to enjoy the week, a 'behavioural contract' will be drawn up between the group at the start of the week. Any child failing to achieve this standard of behaviour will be asked to leave and no refund will be given.
- At **2.30pm on Friday 6th August**, the children will present their performance of Chitty Chitty Bang Bang. Please indicate and complete the Ticket Request Letter at Monday's registration to let us know how many tickets you would like for this.
- Please note that some filming and photography may take place during the week by LTH or Brightlights Theatre School staff but is **not allowed** during the performance, in keeping with standard practice in the industry. Permission for your child to be photographed by LTH and Brightlights Theatre School can be given in the Consent Form included in this pack and these photographs will be made available for parents on request. We thank you for your co-operation with this.
- Please be aware that a child attending has a relatively severe nut allergies, please bear this in mind when considering packed lunches for your child to bring to Show in a Week. We are asking all parents to not include traces of nuts in packed lunches, and really appreciate your cooperation.

Child Safety

All supervising adults have been DBS checked for previously working with children. Where applicable, the venue has authorised the portability of previous checks.

All adults working with children have been briefed on Charnwood Borough Council's Safeguarding Policy and Procedure and we have received the companies Child Protection Policy.

If consent is NOT given for self-sign out/in, each day your child will need to be signed in and you will need to verify the emergency contact and the collection details for that day. Your child will not be allowed to leave Loughborough Town Hall until collection, by the named collector for that day. At this point your child will be signed out and no longer the responsibility of Loughborough Town Hall.

Where consent IS given for self sign out/in, children who are permitted to self sign-out must do so with the designated member of staff each day.

The health and safety rules of the building will be outlined to your child at the start of the week and the workshop leaders will remind them of these when moving around the building.

Please make sure that all the medical details we have for your child are correct and that all medication needed has been clearly labelled with the child's name.

Please make sure we have any Access requirements prior to the start of the week, to ensure your child can be fully accommodated for during *Show In A Week*.

COVID-19 Safety Precautions

In keeping with best practice, Loughborough Town Hall will be putting in place the following measures:

- **All children are to be registered from the side entrance of Loughborough Town Hall, which is located in the Town Hall Passage.**
- **All pupils will be temperature checked on arrival each day.**
- **There will be a one way system in operation throughout the building which children will be made aware of.**
- **Hand sanitiser stations will be available for all use.**
- **The Main Hall space is well ventilated, ensuring fresh air is pumped from outside.**
- **Staff throughout the building will be wearing masks/face coverings.**
- **We are undertaking an enhanced cleaning regime in all public areas of the venue.**

We ask that should your child or anyone in the household develop symptoms of Coronavirus, or are requested to self-isolate by NHS Test and Trace, that they stay home and complete a test. We ask you also call the Box Office to inform us of this.

If, following your child attendance at Show In A Week you begin to present symptoms of Coronavirus, you should get tested and self-isolate as soon as possible.

If you receive a positive diagnosis, NHS Test and Trace will be in contact to establish where you have been recently and who you have come into contact with. They will then follow this up with us as a venue and advise on next steps for all concerned, and all customers should ensure they follow the NHS guidance provided.

Friday afternoon final performance

Tickets for this performance will be limited to 6 per child (subject to change). On the day, Ushers will place each group in a specific area and we ask for your co-operation throughout.

Should any member of your group have any additional needs, please let us know on the ticket letter provided separately.
